Meeting was called to order and welcome given at 10:32 AM, by President Jim Cochran.

Meeting minutes from the 2022 Annual Meeting were reviewed and motion was made by Courtney Glover to approve the minutes, second by Diane Higgins. Minutes are approved and placed in the Corporate Record Book.

Bobby reviewed the Financial Report, which included the 2023 Budget and expenses to date. Jean Gillman wanted to know if dormers were repaired? Advised dormers have not been repaired as it would cost approximately \$5,000.00 to do all buildings. We just paid \$1100.00 to Critter Control to remove raccoons from premises.

Discussion was held on Reserve Study. Special Meeting will be held when we receive from Criterium Liszkay Engineers. Don Spears inquired about the cost of Reserve Study. Cost was \$3800.00.

Handbooks were handed out at the meeting. Everyone agreed they were nice to have.

Nominations were held for Board Member. Jim Cochran was reelected for another three year term.

Advised everyone that we were having a Labor Day Cookout. Association would provide hot dogs, hamburgers, brats, pulled pork, baked beans, mac and cheese, paper products, silverware and drinks. Asked everyone to please attend and to bring a side dish or dessert ( not mandatory), but to please come eat and enjoy meeting your neighbors.
